The document verification shall be carried out in the Gopabandhu Auditorium of the institute. The provisional selection on the basis of merit shall automatically stand cancelled if the candidate is not present physically within the stipulated time and submit the required documents and fees at the time of counseling and the seats shall be filled up by the remaining qualified candidates of the merit list.

The candidates shall only be allowed to take admission on producing their valid photo identity card (such as Voter ID card, Aadhar card, PAN card, driving License, Pass Port etc.)
