Applications are invited in the prescribed format for the post of Pharmacist on contractual basis for Indira Gandhi Institute of Technology, Sarang, Dhenkanal. The prescribed application form can be downloaded from the institute website www.igitsarang.ac.in. The candidate should enclose a Demand Draft of Rs.500/- (Rupees Five Hundred only) [Rs.200/- (Rupees Two Hundred only) for SC/ST] drawn in favor of "Indira Gandhi Institute of Technology, Sarang" payable at State Bank of India, IGIT Sarang (Code: 10246) along with the application form. The Applicants in employment at present should apply through proper channel. The last date of receipt of complete Application Form is **30th August, 2019**.

Name of the Post: - Pharmacist

Category: - Unreserved

Number of Vacancy: - 01 (One)

Monthly remuneration: Rs.9500/- in first year and annual increase of remuneration as per the Govt. of Odisha service rule subject to satisfactory performance.

Eligibility Criteria: In order to be eligible for contractual recruitment to the post of Pharmacist, a candidate shall have to satisfy the following conditions, namely:-

- a) Nationality- She/He must be a citizen of India;
- b) Age limit- She/He must have attained the age of 21 years and must not be above the age of 32 years on the date of advertisement for the post;
- c) Knowledge in Odia- The candidate must
 1. be able to read, write and speak Odia,
 2. have passed Middle School examination with Odia as language subject; or
 3. have passed matriculation or equivalent examination with Odia as medium of examination in non-language subject;or
 4. have passed in Odia as language subject in the final examination of class-VII from a school or educational Institution recognized by the Government of Odisha or the Central Government;or
 5. have passed a test in Odia in Middle English School standard conducted by the School and Mass Education Department.
- d) Marital status- If married, the candidate must not have more than one spouse living; provided that the Government may, if satisfied that such marriage is permissible under the personal law applicable to such candidate or there are other specific grounds for doing so, exempt any candidate from the operation of this rule.
- e) Minimum Educational Qualification- The educational qualification of the candidate for the contractual post of Pharmacist shall be as specified as:
Must have passed +2 Science Examination under Council of Higher Secondary Education, Odisha/ equivalent and Diploma in Pharmacy from any of the Medical College and Hospitals of the State/ any other recognized private Institutions duly approved by AICTE and Examination conducted by the Odisha Pharmacy Board.
- f) Physical Fitness- The candidate must be of good mental and physical health and free from any physical defects likely to make him incapable of discharging her/his normal duties in the Service.

- g) A candidate who after such medical examination as the Government may prescribe is not found to satisfy these requirements as specified in clause (f) shall not be appointed to the Service.
- h) He/She must have registered his/her name in Pharmacist Council in the State and have possessed valid registration Certificates as on the date of the advertisement.

General Information:

1. The Institute reserves the right to fill-up or not to fill-up the post advertised or even to cancel the entire selection process without assigning any reason thereof.
4. No correspondence whatsoever will be entertained from the candidates regarding postal delays, conduct and result of selection and reasons for not being selected. The decision of the Institute in all matters is final.
