Eligibility criteria to participate for B.Tech (LE), MCA, M.Tech, M.Tech (PT) spot round counselling.

- (a) Student having a valid JEE Main/OJEE/GATE Rank
- (b) The candidates, who have not participated on earlier rounds of OJEE counselling / who have withdrawn from the OJEE counselling process.
- (c) The candidates who have participated in earlier rounds of OJEE counselling but have not got allotment of seats / allotted a seat but not considered further due to any reason.
- (d) The candidates who have been issued final allotment letter after final round of OJEE Counselling but did not report at their allotted institution.
- (e) Students those who are willing to take admission under EWS category, must have the valid EWS certificate.
- (f.) Students should come prepared to deposit the counselling fees of Rs. 450/- and admission fees of Rs. 39500/- and Rs. 83600/- (B.Tech (CSE) and M.Tech Environment Science Engg. (PT) & IPCD (PT) only through online mode after the spot round allotment.
- (g) OJEE counselling rules are applicable for admission to the vacant seats.

N.B: After allotment/admission on 13/09/2024 the revised vacancy for round 2 spot admission will be published in the Institute website on 13/09/2024 after 6.30 PM.
