Students are advised to down load the registration form from the Institute website. Further ,students are advised to attend classes positively as per the schedule given below to avoid shortage of attendance, Students are to register in person(NOT IN ABSENTIA)

Fees to be deposited:

1. Registration Fees through SBI Collect Bank under the category Misc. Institute fees.
2. Examination Fees through SBI Collect under the category Misc. Exam. fees.
3. 3rd and 5th semester Diploma Registration Fees Rs 4850/-for General students(Rs 2350/- for TFW ,SC/ST & PH) students. Examination Fees -Rs 50/- for all students.
4. Procedure for deposition of dues online using state bank collect facility is available in the IGIT Web Site -www.igitsarang.ac.
5. Students those who are to pay the fees on Bank loan from different Banks can also deposit the fees through their Bank in the Institute Bank Accounts (A/C No-37716788959 for Institute Fee and A/C No-37718855596 for Examination Fee in SBI IGIT Sarang IFSC Code No-SBIN0010246 NEFT/RTGS system and produce the receipt at this Institute along with the registration forms. In this connection , students should deposit the exact fees as per the notice , into respective Bank account.
6. Students those who have studied in 3rd and 5th semester but could not qualify to appear the semester examination winter(2022-23) due to shortage of Bio-Metric attendance will be allowed to take admission in the same semester i.e 3rd and 5th semester 2023-24. They have to deposit the fees as prescribed. This chance is given only once.
