1. Registration Fees Bank A/C No-37716788959 under the category institute fees.
2. Examination Fees Bank A/C No-37718855596 under the category Misc. Exam. fees.
3. 3<sup>rd</sup> and 5<sup>th</sup> semester Diploma Registration Fees Rs 4850/- for General students (Rs 2350/- for TFW, SC/ST & PH) students. Examination Fees -Rs 50/- for all students.
4. Procedure for deposition of dues online using state bank collect facility is available in the IGIT Web Site -www.igitsarang.ac.in SBI IGIT Sarang IFSC Code No-SBIN0010246
5. Students those who are to pay the fees on Bank loan from different Banks can also deposit the fees through their Bank in the Institute Bank Accounts as above under NEFT/RTGS system and produce the receipt at this Institute along with the registration forms. In this connection, students should deposit the exact fees as per the notice, into respective Bank account.
6. Students those who have studied 3<sup>rd</sup> and 5<sup>th</sup> semester but could not qualify to appear the semester examination winter (2021-22) due to shortage of Bio-Metric attendance will be allowed to take admission in the same semester i.e 3<sup>rd</sup> and 5<sup>th</sup> semester 2022-23. They have to deposit the fees as prescribed. This chance is given only once.
