



All colleges to deposit the fees with fine if any, in BPUT Examination Fund – SBI, SB AC No : 38934428116, IFSC Code SBIN0002112, Sector-19, Rourkela Township, Sundergarh on or before 22.12.2022 failing which the students shall not be allowed to appear the Examination. The colleges after depositing the fees are required to send the copies of the deposit slips in response to the earlier notices along with the deposit slip of payment for additional students registered in response to the current notice.


