(d) No bank guarantee shall be accepted in lieu of the EMD.

FORFEITURE OF EARNEST MONEY DEPOSIT (EMD)

The EMD shall be forfeited by the IGIT, Sarang in the following events:


12. The offered rates will be valid initially for a period of one year.

TERMS AND CONDITIONS

1. Tenders should be Type Written or Computerized and every correction in the tender should invariably be attested with signature by the tenderer with date before submission.
2. The tenderer should be a registered firm under GST.
3. The quoted rate should be exclusive of all taxes and the manual should be provided for the items.
4. The rates quoted by the bidder should be complete for supply and installing of the finished items as per the specification(s) and shall be inclusive of all applicable tax, loading, unloading, packing, transportation to IGIT, sarang and installation and nothing extra/additional shall be payable on these rates.
5. Any conditional tender will not be accepted.
6. In case of Distributor participating in tender process, they have to furnish Manufacturer's authorization in the tender.
7. The Manufacturer of Instruments & Equipments must be ISO & CE Certified Organization.
8. No advance payment will be made against execution of order. The required items procured in credit basis against different orders and payment will be made on submission of bills in triplicate to the undersigned. The institute shall make all payments through NEFT in Indian rupees. Necessary bank mandate detailing bank account number etc. shall be submitted by the vendor after execution of agreement.


9. The rate should be valid up to one years from the of finalization of the tender.
- 10.All items should be I.S.I standard.
- 11.The materials are to be carefully packed and insured against breakage / pilferage and losses during transit.
- 12.Defective supplies will be rejected and returned at the cost of suppliers.
- 13.The supplier has to ensure the rectification of defects within **seven days** of the complaint during the period of warranty.
- 14.The warranty period for all the instruments and equipments must have for two years. If any instruments and equipments is not having such warranty period ,the tenderer should provide the above said warranty period and the difference amount to cover the warranty will be paid by the institute.
- 15.Selection of items may be followed by selection of samples as per given specification where ever necessary.
- 16.Proof of compliance with IEC Certificate -Medical Electrical Equipments, particular requirement for Electrical Safety of the equipments.
- 17.The tenderer should depute a technical person for demonstration of the tender items with specification before the members of selection committee whenever necessary.
- 18.Tenderers qualified after opening of the technical bid will be called for opening of the financial bid.
- 19.No tender beyond the stipulated date & time will be accepted and tenders without EMD will not be considered.
